#### Jargon buster

**Beneficiary** – a person or charity benefiting from a gift in your Will.

**Bequest/legacy** – a gift in your Will to any person or charity.

**Codicil** – a legal postscript to your Will which makes a valid legal change or addition to your Will.

Estate – total sum of all your possessions.

**Executor** – a person charged with ensuring that your wishes expressed in your Will are carried out. Executors can also be beneficiaries.

**In memoriam gifts** – these are gifts to a charity (such as VTST) which are in place of flowers at a funeral where only family flowers might be desired.

**Inheritance Tax** – the tax levied on your estate if over a certain amount. The inheritance tax threshold for married couples is £650,000. Any amount over this sum is taxed at 40%. If you leave a legacy to VTST, the value of the legacy is deducted before being assessed for inheritance tax. An estate will reduce its tax bill by leaving VTST a gift in a Will. If you leave 10% of your estate to charity the tax due may be paid at a reduced rate of 30% instead of 40%.

Intestacy – dying without a Will.

**Pecuniary legacy** – A legacy gift in the form of a sum of money.

**Probate** – official proof of a will's validity. If the value of the estate is more than £15,000, probate must be applied for by the executors who can then administer the will and distribute the estate according to your wishes.

**Residuary legacy** – a gift of what is left of your estate (or part of, such as 10%) after all debts, taxes, costs and other legacies.

**Reversionary legacy** – a legacy to a person or charity which is only passed onto the beneficiary after the lifetime of another you want to benefit first (such as your wife or husband).

**Specific legacy** – a gift of a particular item in your Will.

**Testator** – person who has made a Will.

**Witness** – a witness of your signature on your Will – a witness cannot be a beneficiary.

- ▲ To prepare for the end of flying operations so as to permit active ground operations for the aircraft after retirement, with access for the aircraft's supporters & the general public.
- ▲ To advance the education of the general public. Specifically, to use the aircraft, its restoration programme, its design and purpose and its iconic status in the history of British engineering as the centrepiece of a facility to inspire young people into engineering.

### Remembering The Vulcan To The Sky Trust in your Will

It is important that people consider their spouse, family and friends first when leaving gifts in their Will.

A gift in your Will can be any size. £50 is welcome, so is £5 million. 1% of your estate would be wonderful, or any other percentage which helps ensure the future of XH558.

It's only natural that you would want your spouse to benefit from the whole of your estate during their lifetime. If you are happy to remember the VTST in your Will, you can ask your professional adviser to draft a Reversionary legacy after you have passed away, which would only come to the VTST after your spouse has subsequently died.

If you are thinking of including VTST in your Will, or have already done so, then a BIG thank you!

The words you can use are as follows:

Residuary gift in a Will (a percentage of your estate)

#### Cash gift in a Will

I give free of tax to The Vulcan To The Sky Trust, I & 2 Venture Court, Dodwells Road, Hinckley, Leicestershire LE10 3BT, Charity Number I101948 the sum of £......... (words and figures) to be used for its general charitable purposes, and I declare that the receipt of their Treasurer or other proper officer shall be a full and sufficient discharge.

If you want to leave the "Reversionary legacy" we mentioned, it is important for your professional adviser to understand your personal circumstances before drafting such a gift.

#### Tax doesn't have to be taxing

We would like to emphasise that it is really important to take professional advice when preparing your Will. Ideally you should use a solicitor who might also help you avoid inheritance tax if it applies. If you do not have one, find one online via www. lawsociety.org.uk/find-a-solicitor

All gifts to charity are wholly exempt from inheritance tax. The value of your estate for tax assessment is reduced by the value of your gift, so that the tax can be reduced or eliminated.

Please do not hesitate to contact us if you are considering remembering the VTST in your Will.

## Other things to remember when considering making or updating your Will

Help in drafting or changing your Will

To make everything easier for those who survive you, it is worth taking time to consider:

- Have you appointed an executor of your Will?
- Guardianship of children or dependant relatives
- Have you made provision for your pets?
- Whether you would prefer to be buried or cremated
- ▲ Whether you would like flowers from everyone, or just the family, and instead ask for donations to a charity such as VTST.
